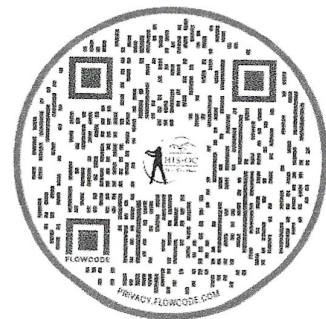

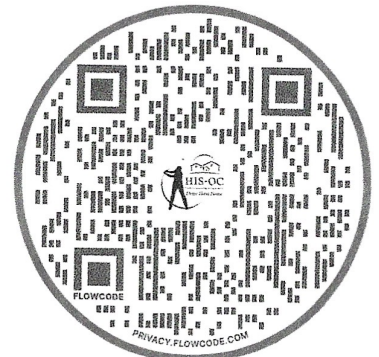

Dear Applicant:
